This pertains to your letter seeking permission to conduct the following face-to-face activities amid General Community Quarantine (GCQ) on December 3 to 4, 2020, to wit:

1. A two-day writeshop on Contextualizing Self Learning Modules in Television-Based Instruction at JB Hall, Heroben Homotel, Osmeña Extension, Tagum City; and
2. ALIVE Validation and Finalization of Structured Arabic Language Learning Package for Grade 2 at Napoleon Hall, Miko's Brew, Apokon, Tagum City.
